Pursuant to Woburn Municipal Code Title 3, Article I, Section 3-3(C), and to Rule 31 of the Rules and Orders of the City Council, the President of the City Council has called a Special Meeting of the City Council for Monday, June 10, 2013 at 7:00 p.m. in the City Council Chambers, Woburn City Hall, 10 Common Street, Woburn and further, if necessary, the proceedings will continue at a Special Meeting of the City Council on Tuesday, June 11, 2013 at 7:00 p.m. in the City Council Chambers, for the purposes of reviewing, conducting a public hearing and taking action as determined by the City Council on the Fiscal Year 2014 Budget, taking action on financial matters presented and pending before the City Council, taking action on financial matters pending in Committee on Finance, providing a first reading for financial matters, and for any other matters that may legally come before the City Council, and, at the time of posting, a listing of topics that the President reasonably anticipates will be discussed are as follows:

1. Roll Call.
2. Reading of Previous Meetings Journal.
3. Public Hearing: Pursuant to Woburn Municipal Code Title 3, Article I, Section 3-3(C), the City Council of the City of Woburn shall hold a Public Hearing on the Fiscal Year 2014 City of Woburn Annual Budget.
4. Discussion and action on the Fiscal Year 2014 budget.
5. Transfers, appropriations and Orders:
  - a. Reauthorization of the following revolving funds: Spence Farm, Conservation Commission, Police School Resource Officer, Board of Health Landfill Closure, Council on Aging, Recreation Basketball, DPW Liberty Elm Tree Program, Be Well Woburn Committee.
  - b. Authorize the Cable Television and Telecommunications Revolving Fund.
  - c. Order to transfer \$2,000 from Treasurer Sick Leave Buy Back Account to Treasurer Lock Box Fees Account.
  - d. Order to transfer \$4,748.50 from Assessor Salary Account to Purchasing Sick Leave Buy Back Account.
  - e. Order to transfer \$40,000 from Police Holiday Pay Account to Police Overtime Account.
  - f. Order to transfer \$37,000 from Police Regular Salary Account and Police Court Overtime Account to Police Reserves Account.
  - g. Order to transfer \$35,000 from Police Ammunition Account, Police Lighting Account and Police Heat Account to Police Firearms Account.

- h. Order to transfer Police Diesel Account to Police Gas Account.
  - i. Order to transfer \$19,521.41 from Police Sick Leave Buy Back Account and Police Holiday Pay Account to Police Detective Equipment Account.
  - j. Order to transfer \$42,235.29 to DPW Sick Leave Buy Back Account and DPW Gas Account.
  - k. Order to transfer \$230,000 to Fire Regular Salary Account.
  - l. Order to transfer \$90,000 to Ambulance Salary Account.
6. Any other matter that may legally come before the City Council.
