A. SUB-BID DATE FOR SECTION 230001-HEATING, VENTILATING AND AIR CONDITIONING

1. As a result of a bid protest filed with the Attorney General's office, the Awarding Authority has rejected all the sub-bids received on 06 April 2021 for SECTION 230001-HEATING, VENTILATING AND AIR CONDITIONING, and the work of this Section is being re-bid.
2. Sub-bids for SECTION 230001-HEATING, VENTILATING AND AIR CONDITIONING will be received until **2:00 PM Wednesday, 12 May 2021** at the following location:

B. CHANGES TO THE PROJECT MANUAL

4. SECTION 230001-HEATING, VENTILATING AND AIR CONDITIONING

- a. Page 230001-1, Article 1.00 TIME, MANNER AND REQUIREMENTS FOR SUBMITTING SUB-BIDS, subparagraph D, item 2, revise classes of work paragraph to read as follows (revision in bold):

- b. Page 230001-76, Article 2.24 TAILPIPE EXHAUST SYSTEMS, delete paragraph A in its entirety and substitute the following:

“A. *Acceptable manufacturers: Plymovent, Nederman, Magnegrip or approved equal.*”
